## WEBCASTING SESSIONS

### Pre-Billing Audits: Why Bother? Tuesday July 28, 11am-12:30pm (PST)

This session is to discuss the significance of prebilling audits and what issues could arise if they are not conducted. NonRoutine Supply details will be reviewed during the session with focus on the repercussions to the agency if the supply protocols are not followed.

### Cost Efficiencies in Back Office Staffing & Structure Thursday August 13, 11am-12:30pm (PST)

This session will assist agencies in drilling down into processes, paperwork flow, technology efficiencies/ deficiencies and much more. Agencies must achieve the highest level of cost efficiencies possible in the back office as well as in clinical care. This session is sure to highlight spots of cost efficiency consideration that the agency may not have investigated before.

### Recovery Audit Contractors - What are they looking for? Thursday September 17, 11am-12:30pm (PST)

This session will review the goal of the RAC audit process. Agencies will learn how to respond to the RAC record requests as well as the subsequent audit findings. The recoupment process will be defined. Lastly, this session will describe likely audit risks for home health agencies and how to monitor those risks.

### OASIS-C: Are you Prepared for January 2010 Thursday October 15, 11am-12:30pm (PST)

This session is ideal for any home health agency employee that has to complete, review, input or audit an OASIS document. The OASIS changes will be reviewed and reimbursement implications will be outlined. Agencies MUST be prepared by January 2010.

### OASIS-C Process Improvements & Outcomes Thursday November 12, 11am-12:30pm (PST)

This session will deal specifically with the NEW process improvements and Outcomes items from OASIS-C. Tools will be supplied on these items. The OASIS-C items that affect Home Health Compare Outcomes will be thoroughly discussed. Audit review processes that should be in place internally will be outlined.

### 2010 Rate Changes & Billing Update Thursday December 10, 11am-12:30pm (PST)

The session will cover the new PPS rates for 2010 and the affect on the calculation of payment for the 2010 HIPPS codes. This session will review any billing updates or changes that will affect processing of claims. Keeping on top of home health reimbursement!
