This year, over 28 attendees gathered in Los Angeles, California for CAHSAH's three-day Home Care Executive Certificate Program (HCECP). The program consisted of three modules that were led by well-known industry speakers including Jeannee Parker Martin with The Corridor Group, Bill Dombi with the National Association for Home Care and Hospice, and Lynda Laff and Pat Laff with Laff Associates. This three-day program focused on topics that provided experienced administrators with the insight to strategically position their organization for success. The first day began with Module I, focusing on understanding the relevant legal issues and corporate compliance followed by real-life case scenarios.
