Candidates who successfully complete the examination are awarded the Certificate for OASIS Specialist – Clinical (COS-C) designation.

Candidates will not be tested on OASIS-C until its date of implementation, and until that time candidates will continue to be tested on current OASIS-B1 items and rules.
