Please Note

1. The Hospice Administrator Certification Examination consists of 100 multiple choice questions that measures competency as a hospice administrator as well as understanding of the HACP program content. All information included in the examination is not taught during the three day program.
2. A pass rate of 80% is required to receive the certificate as a Certified Hospice Administrator (CHA). The exam results will be mailed approximately six weeks following successful completion of the exam. A frame-able certificate will be included for pass rates of 80% or higher. The certification expires four (4) years from the examination date.
3. Continuing education certificates for 18 CEUs will be distributed at the completion of Day 3. Full attendance is required to receive continuing education credits. Partial attendance certificates or partial continuing education credits will not be awarded.
4. Full attendance is arrival no later than 15' after the start of the program each day, and departure no earlier than 15' prior to the close of each day. Certificates will not be awarded for partial attendance. Consideration is not given for traffic delays, airport or other transportation issues.
5. There will be a replacement cost of \$25 per Certified Hospice Administrator Certificate or CEU certificate. Contact The Corridor Group, Inc. at (415) 452-4383.
6. Upon completion of the HACP, you may be eligible to take the Hospice Executive Certificate program (HECP) and Hospice Executive Certification Examination.
