## What's it about?

Health care reform will undoubtedly result in changes with far reaching effects on home health agencies, hospices, and home medical equipment (HME) companies. There will, for example, likely be significant changes regarding patients' right to freedom of choice of providers. Increased utilization of telemedicine makes it important for providers to know how to manage their risks related to its use. Providers will likely also be subject to more stringent fraud and abuse compliance requirements. The purpose of this audio-conference is to provide insight and details regarding these changes with an emphasis on practical application to operations.
