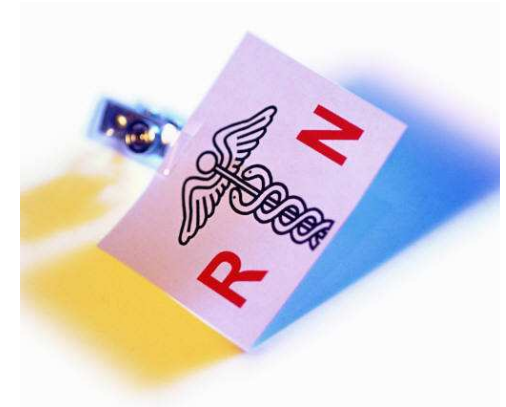
Continuing Education:
